- h. Long-term or rapid decline in participation or membership.
- j. The consistory requests supersession.

Results

By email voting the Classis established a quorum and voted 46-1 to approve the Classis superseding the Consistory of Aberdeen Reformed Church **effective July 23, 2021**. The email voting results are 46 Yes, 1 No.

The Executive Committee appointed a Board of Trustees to oversee disbanding the congregation and dissolving the Aberdeen corporation with the State of Michigan. These members are Ralph Robrahn, John Jacobitz, Tim Elzinga, and Rob Teitsma (Ex Officio). The immediate intent is to sell the church building and property.

It is always difficult to see the end of a congregation's life. However, we can be comforted by the assurance in Ecclesiastes 3:1, "There is a time for everything, and a season for every activity under heaven:..." and verses 14-15, "I know that everything God does will endure forever; nothing can be added to it and nothing taken from it. God does it so that men will revere him."
