Appoint Tellers

Tellers were appointed from Standale.

Approval of the Agenda

Motion made, supported, and passed to approve the agenda as presented.

Approval of Previous Meeting Minutes

Motion made, supported, and passed to approve the minutes of the September 27, 2022.

Committee and Team Reports

Executive Committee

Presentation by Nancy Boote and Kristen Meyer on the RCA's antiracism policy and recommendation by Executive Committee to adopt the same for the Classis. They gave background on the recommendations from General Synod. Kristen introduced CORE, an organization, that provides training for churches who want to address antiracism.

Will the Classis have a concerted effort to develop this concept or just accept it? It is up to the will of the body as to how it moves forward. We need to put our faith into action; we don't need a policy.

Motion made, supported, and passed to adopt the antiracism policy of the RCA.

Billy Norden reported on progress made by the Finance Task Force and highlighted components of the Task Force's findings. A final report with recommendations will be made at the March stated session. Several people spoke to specific uses of money—supporting RCA missions and funding antiracism programing of some type. Consider adding to Classis staff in the form of a Classis Leader. Emphasize support to churches like Servant's and Richmond as they revitalize their ministries.

Motion made, supported, and passed to ratify the following recommendations in one action.

Approved a restated budget including an omitted salary aid assessment of \$3.15.

Recommend the Classis ratify this action.

Approved appointing Ralph Robrahn to an at-large position on the Executive Committee, term ending September 17, 2024; Peter TeWinkle to an extra position on the Specialized Ministry Committee, term ending September 17, 2024; and James Earley to the Student Care Committee, term ending September 16, 2025.

Recommend the Classis ratify this action.

Appointed Jan Koopman to an elder position on the Pastoral Care Committee, term ending September 16, 2025.

Recommend the Classis ratify this appointment.

Voted to a) pay up to \$2,297 in medical co-pays for David Mayer and b) to grant him retirement status effective December 1, 2022. Note: David states that he will be active in our Classis, and in the Freedom Dreamers ministry for Returning Citizens and his Legacy Pals ministry.

Recommend the Classis ratify this action.

The President led a discussion of "How do we fit into today's RCA and Classis?" This was a general discussion using the questions posed by the Regional Synod.

The participants broke into smaller groups for a brief discussion on the future of the Classis. Discuss what is the most fruitful path forward for our Classis.

Comments:

Need to develop a new vision statement. Smaller classis size can be a benefit to Classis function and effectiveness. Put emphasis on people and time fostering more vision development.

Competing visions for restructuring dependent on what General and Regional Synods are going to do.

How can the Classis leverage the unique opportunities to do ministry together?

Importance of local relationships; affinity model with like minded people is detrimental to informed function and ministry. Classis needs diversity of thought to represent the dissimilar beliefs of many church members.

Can we financially continue long term? If merging with GLCC for example, what is the impact on NGRC? Distance between churches makes for a more productive classis session due to the various ministries represented.

Desire for relationship based on group's experience in other classes. Longer meeting sessions due to distance traveled proved effective in building relationships and sharing ministry experiences. The Classis needs to allow ministries to share successes, needs, and wants and encourage each other. The Classis must foster the desire to see other churches do well.

Desire to be effective as a group. Want to keep NGRC together.

Finance Committee

- 1. General Synod Assessment expense line item has been corrected to \$94,987, an increase of \$16,615.
- 2. Regional Synod Assessment Expense line item has been corrected to \$31,414, an increase of \$5,495.

Both above increases are the result of an incorrect assumption by the Chairman of the Finance Committee that assessments for departed churches would be due only until the end of 2022. By General Synod rule those assessments must be paid up to the 12th month after a Petition for Withdrawal has been filed.

To reflect above items 1. and 2., General Fund expenses increases from \$130,335 to \$152,445. To reflect above items 1. and 2., Net Cash shortfall increases from \$43,397 to \$65,507.

Motion made, supported, and passed to approve the revision to the 2023 budget.
