Classis of North Grand Rapids Meeting Minutes

Stated Session March 21, 2023 Oakview Reformed Church

Opening: Devotion led by Ben Bruins including a reading of Psalm 130 and prayer. Sarah Van Zetten Bruins led the classis in singing the Doxology.

Dr. Craig Mattson (Craig E. Mattson, PhD, Arthur DeKruyter Chair in Faith and Communication, Department of Communication, Calvin University) led a workshop about two kinds of stories we can tell about our churches and organizations. The first is a "hero's story." It focuses on an individual encountering a problem, getting a mentor, forming a community, and achieving success. The second is a "neighborhood story." It starts in a place that has hidden resources. A catalyst makes those resources visible and sharable. The neighborhood experiences "enoughness."

Both stories are good to tell but it is problematic to rely only on a hero's story because it is individualistic, blind to privilege, and doesn't speak to those times and places in life when we don't win such as in Ecclesiastes 2.

Approval of the Agenda

Motion made, supported, and passed by consensus to approve the agenda as presented.

Approval of Previous Meeting Minutes

Motion made, supported, and passed by consensus to accept the minutes of the January 17, 2023.

Appoint Tellers

Tellers were appointed from The Community – Ada and Third.

Committee and Council Reports

Finance Committee

Finance chair Tim Elzinga described the current state of the classis's finances and anticipated negative cashflow of \$108,978 in 2023 and a negative cashflow of \$65,036 in 2024. If nothing changes, classis will continue to operate with a structural deficit of about \$40,000. The Finance Committee plans to recommend budgets that gradually increase classis assessments over a ten-year period until the structural deficit is closed.

Tim presented on the decision classis will make in September about switching to a covenant shares model of assessments or continuing with our current model. If we switch to a covenant shares model, some churches will see 10% increases for up to 6 years. The Finance Committee will provide each church with information about how they would be impacted after General Synod and Regional Synod finalize their numbers this summer.

Executive Committee

The Executive Committee recommended the following Stewardship Plan, adapted from the Stewardship Task Force proposal and grant applications for the remainder of calendar year 2023.

Richmond Reformed Salary Assistance — \$50,000

Servant's Community Church Capital Improvement Projects — \$40,000

Student Care Committee for student psychological evaluations and tuition assistance — \$12,000

On-Mission Grants — \$50,000

Using the criteria proposed by the Stewardship Task Force, grants to be reviewed by the Executive Committee.

Clergy Renewal — \$25,000

Using the criteria proposed by the Stewardship Task Force, grants to be reviewed by the Pastoral Care Committee.

Antiracism Grants — \$10,000

Antiracism congregational initiatives and subsidizing Sankofa trips, grants to be reviewed by the Executive Committee

Recommended total additional reserve fund to be spent in 2023 is \$187,000

Billy Norden, chair of the stewardship task force made a motion to divide the question and consider requests for funding church grants separately from the rest of the Executive Committee recommendation. This motion was made, supported, and did not pass by a show of hands.

There was further discussion from the floor in favor of the principles behind Billy's motion that more grant-like process of evaluations and metrics be put into place by the Revitalization Committee for any churches requesting funds.

Jeffrey Peterson made a motion to amend the Executive Committee recommendation so that any funds granted to congregations be repaid in full if they depart the Reformed Church in America within 5 calendar years of when the funds were granted.

The amendment was seconded and approved.

James Early made a motion to amend the amended Executive Committee recommendation so that the grant to Servants Community Church would require the church to submit receipts to be reimbursed by the classis on up to \$50,000 of capital improvement expenses. The amendment was seconded and defeated.

The Executive Committee recommendation, with the amendment that any funds granted to a congregation be repaid in full if they depart the Reformed Church in America within 5 calendar years of when the funds were granted was approved.

Classis Expansion

The Classis has been approached by The Branch, a Great Lakes City Classis (former South Grand Rapids Classis) congregation about transferring to North Grand Rapids. Any decision to transfer is solely the Regional Synod's to make with input from the dismissing and receiving Classes.

One of the first steps in the transfer process is for the congregation seeking to transfer classes to provide the regional synod written evidence that they would be received in the classis they desire to transfer into without reservation.

Ben Bruins read from the email the classis received from the Branch asking if we would be willing to receive them without reservation.

Ben invited Chris DeBlaay, pastor at the Branch, to introduce himself and provide a brief history of the church. Chris answered questions about the Branch from the floor. Ben answered questions about the transfer process.

A motion was made to instruct the clerk of the NGR Classis to inform our regional synod that we would receive The Branch without reservation and to instruct the executive committee to create a policy for receiving transfers. Seconded.

An amendment was made to instruct the executive committee to create a policy for receiving transfer congregations to recommend to the classis at the September meeting. The motion to amend was seconded and approved.

The amended motion to instruct the clerk of the NGR Classis to inform our regional synod that we would receive the Branch without reservation and to instruct the executive committee to create a policy for receiving transfers to recommend to the classis at the September meeting was approved.

A suggestion was made on the floor that executive committee consider distance of the churches as part of the policy, remembering the difficulty of a classis congregation in Franklin, Tennessee.

A suggestion was made that the executive committee articulate that our classis is committed to living with theological diversity regarding congregational convictions about human sexuality.

President's Report – Ben Bruins

Ben highlighted the inclusion of the presidential report in the agenda email.

Overtures and Judicial Business

OBJ presented a proposal for changes to the Rules of Order reflecting the changing size of the classis and providing greater organizational flexibility. The intent is for members to review the proposed changes and provide feedback to the classis clerk before August 2023. The Executive Committee will incorporate feedback and plan to do a first reading at the September 2023 meeting.

Jennifer Peterson requested that the Executive Committee email the classis a copy of the current rules of order along with the proposed rules of order.

Specialized Ministry Committee

Motion made, supported, and passed to designate Eric Bogerd and John Delger as specialized ministers filling chaplaincy roles.

There was discussion on the floor for the committee to consider renaming the category of "not in good standing".

Commissioned Pastor Team

Motion made, supported, and passed to cede the Commissioned Pastor examination of Scott Rose to the Southwest Michigan Classis and to instruct our clerk to write the Southwest Michigan Classis that Scott Rose has met all of the study requirements of North Grand Rapids Classis.

Motion made, supported and passed to grant Kathy Bartels retirement status.

Kathy was thanked for her years of ministry and received a round of applause.

Petition to Withdraw – Rockford Reformed Church

Motion made, supported, and passed to grant the withdrawal of the Rockford Reformed Church from the Reformed Church in America effective March 22, 2023.

A motion was made, supported, and passed to demit the ordinations of Eric Cook and Todd Schmidt at their request.

2023 State of Religion Report Classis of North Grand Rapids

Our classis has been transformed by the departure of five congregations. The departing congregations reported leaving to seek doctrinal purity regarding their interpretation of human sexuality and a polity they believe will be more functional for them. Four of these congregations transferred to the recently created Alliance of Reformed Churches; one transferred to the Wesleyan denomination.

The departure of these five congregations raises several questions for our classis.

- 1. Is our polity too cumbersome and outdated to effectively help a theologically diverse body live in covenantal relationship?
- 2. Given the loss of human and financial resources, is our classis still a viable assembly?
- 3. In our diminished state, how might we move forward as a covenantal community called to witness and participate in God's reign?

As we await General Synod and Regional Synod restructuring proposals, the remnant of our classis is committed to working together so that our assembly will endure in a meaningful form. We recognize the value of serving with long term colleagues and continuing congregational partnerships; we are excited to work with new members of classis and students under care. We reaffirm that classical support and accountability is an important part of our witness as Reformed Christians—it's a way we embody Reformed theology. We are not independent individuals or even independent congregations; we are part of the body of Christ!

The upshot of being a remnant is that those who remain in the classis choose to do so and new levels of trust and cooperation are growing. Classis members are beginning to envision new possibilities, and there is hope that our life together might be better—with deeper relationships, a collaborative sense of mission, and shared resources.

The reality remains that most of our congregations are struggling with budgets, post-pandemic worship attendance, and staffing ministries with volunteers. In our need, we trust that the God of the cross and resurrection will do a new thing among us.

As we trust in Christ, we are discovering the energy to:

- 1. reform our bylaws to fit our size and desire for flexibility
- 2. deploy our classis financial reserves wisely in this transitional moment
- 3. explore the reception of new churches into our classis
- 4. embody our pledge to work against racism in the church and in the world

As a classis, we face deep and persistent challenges. Nevertheless, our comfort remains that "We are not our own, but belong—body and soul, in life and in death—to our faithful Savior, Jesus Christ." Our future is secure in God's hands.

***The BCO requirement is that all points of doctrine in the Heidelberg are exposited upon in worship every four years. At Third we have not utilized the Heidelberg as a guide for teaching in worship and I can't say with integrity that all points of doctrine within it have been explicitly taught in the last four years. In the past I've encourage consistories to loosely understand that BCO requirement, but it seems as though the intent is more narrow and the question is a holdover from the older RCA liturgy which included a Q&A from Heidelberg in each service.

#The consistory felt that Servant's Community Church is growing and developing meaningful formation opportunities for young people. However, in engaging young people's gifts, skills, and vocational considerations, Servant's Community Church has room to grow and improve. We didn't feel "deficient" in this area, per se, but recognized that we could be doing more to encourage our young people in using their gifts for Christ's kingdom.


Dear Rob,

Our projected cash flow for 2024 is (\$65,035.83). Actual reserves beyond 2024 = \$683,686.54

Recommend maintaining a reserve balance of \$120,000 for use in emergencies, which would leave \$563,686.54 of unallocated reserves.

The cost of maintaining our structural deficit (whereby assessments/covenant shares are reduced by pulling money from our reserve funds) is projected to be \$40,000 a year beginning in 2025.

If we use all of our reserved funds and no longer operate with a structural deficit, the nine congregations in classis will need to increase their assessments/covenant share by a combined \$40,000/year.

Recommend reducing the amount of our structural deficit in steps over the course of 10 years. Covering our actual expenses each year will enable us to responsibly deploy our reserve funds.

Additional Requests

Richmond Reformed is requesting \$50,000 a year for three years (total of \$150,000) for salary assistance.

Servant's Community Church is requesting \$50,000 a year for three years (total of \$150,000) for facility improvement projects (in addition to yearly salary support of \$18,000/year).

The Student Care Committee is requesting \$11,000 a year for tuition assistance and psychological evaluations each year in addition to their \$2,000 annual budget.

At the January Classis Meeting the body indicated a desire for antiracism deeds to match the words of the policy we approved.

Proposed Reserve Fund Distributions for 2023

Richmond Reformed Salary Assistance — \$50,000

Richmond's 2023 budget is \$259,087; their 2022 income was \$169,110; their 2021 income was \$223,631.

Richmond has about \$399,094 in endowed funds they are working to gain access to through congregational vote and broadening the definition of "mission" to include work in the neighborhood as well as overseas. \$50,000 will help them cover a gap in the budget as they work to call a new pastor this year.

Servant's Community Church — \$40,000

Classis is already committed to supporting Servant's with \$18,000 of salary support. Servant's is projecting an operating deficit of \$56,000 which they will work to cover with additional fundraising. \$40,000 will help them accomplish most of their first year building maintenance goals.

Student Care Committee — \$12,000

Student Care will be able to provide psychological evaluations for both students under care and offer them tuition assistance for next year's classes.

On-Mission Grants — \$50,000

Using the criteria proposed by the Stewardship Task Force, grants to be reviewed by the Executive Committee.

Clergy Renewal — \$25,000

Using the criteria proposed by the Stewardship Task Force, grants to be reviewed by the Pastoral Care Committee.

Antiracism Grants — \$10,000

Antiracism congregational initiatives and subsidizing Sankofi trips, grants to be reviewed by the Executive Committee

Recommended total additional reserve fund to be spent in 2023 is \$187,000.
